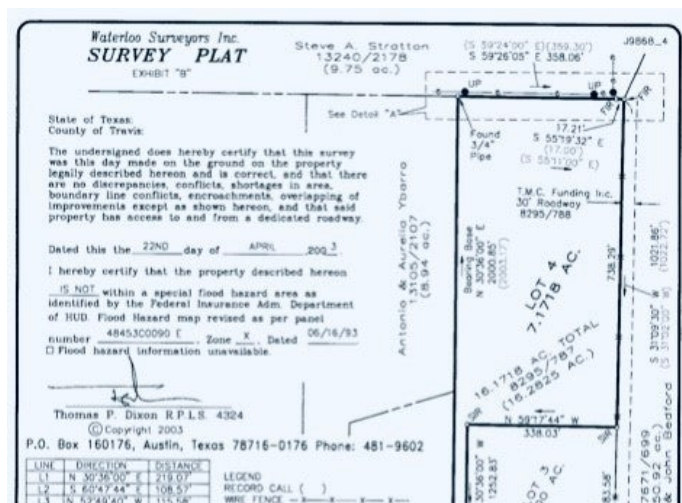

FIELD NOTES

FIELD NOTES FOR 7.1718 ACRES OF LAND, MORE OR LESS, HEREIN REFERRED TO AS LOT 4, OUT OF THE JOSEPH DUTY SURVEY NO. 16 IN TRAVIS COUNTY, TEXAS, SAME BEING OUT OF AND PART OF THAT CERTAIN 16.2825 ACRES OF LAND CONVEYED TO EARCH BROWN RECORDED IN VOLUME 8285, PAGE 787, DEED RECORDS, TRAVIS COUNTY, TEXAS; FOR WHICH A MORE PARTICULAR DESCRIPTION BY METES AND BOUNDS IS AS FOLLOWS:

BEGINNING at an iron rod found on the north R.O.W. of F.M. 969 at the S.W. corner of said 16.2825 acre tract for the S.W. corner hereof:

THENCE N30°36'00"E along the west line of said 16.2825 acre tract for a distance of 2000.85 feet to a 3/4" pipe found at the N.W. corner of said 16.2825 acre tract same being on the south line of that certain 9.75 acre tract of land recorded in Volume 13240, Page 2178, Real Property Records, Travis County, Texas for the N.W. corner hereof:

THENCE the following two (2) courses and distances along the north line of said 16.2825 acre tract

1. S59°26'05"E for a distance of 358.06 feet to an iron rod found;
2. S55°19'32"E for a distance of 17.21 feet to an iron rod found on the west line of a 30 feet wide road referenced in Volume 8285, Page 787, Deed Records, Travis County, Texas at the N.E. corner hereof;

THENCE S31°09'30"W along the east line of said 16.2825 acre tract and the west line of said 30 feet wide road for a distance of 738.29 feet to an iron rod set for a corner hereof, from which point on a pipe found on the east line of said 16.2825 acre tract on the west line of said road bears S31°09'30"W at a distance of 283.58 feet;

THENCE N59°17'44"W crossing into said 16.2825 acre tract for a distance of 338.03 feet to an iron rod set for a corner hereof;

THENCE S30°36'00"W for a distance of 1252.83 feet to an iron rod set on the north R.O.W. of F.M. 969 for the most southeasterly S.E. corner hereof.

THENCE N76°44'55"W along the north R.O.W. of F.M. 969 for a distance of 31.43 feet the POINT OF BEGINNING, containing 7.1718 acres of land.
